1. NOTICE INVITING TENDER (NIT):

Sealed tenders are invited from experienced and licensed electrical contractors / qualified electricians for engaging a qualified electrician on contract basis for the operation, routine maintenance and attending electrification-related works of the Bank's Office buildings (One at Uphill, Malappuram having HT connection of 315 kVA and One at Pallikkunnu, Kannur having HT connection of 250 kVA), in compliance with Electricity Rules, 2003.

2. NAME OF WORK:

Engagement of Qualified Electrician for Maintenance of 315 kVA HT Transformer and Associated Electrical Installations at Head Office building, and 250 kVA HT Transformer and Associated Electrical Installations at Kannur Office building.

3. SCOPE OF WORK:

The scope of work shall include, but not be limited to, the following:

A. Transformer & HT System Maintenance

- ✚ Operation and routine maintenance of HT transformer, HT panel, LT panel, and allied electrical installations.
- ✚ Daily monitoring of transformer parameters (load, voltage, current, temperature, oil level, etc.).
- ✚ Periodical inspection of:
 - ❖ HT switchgear, breakers, relays, cables, earthing
 - ❖ LT distribution boards and feeder panels
- ✚ Coordination with KSEB / Electrical Inspectorate whenever required.
- ✚ Immediate attending of faults, breakdowns, tripping, or abnormal conditions.

B. Compliance & Statutory Requirements

- ✚ Ensuring compliance with Electricity Act, 2003 and Electricity Rules, 2003.
- ✚ Maintaining statutory registers, logbooks, and records as required by authorities.
- ✚ Assistance during electrical inspections by statutory authorities.
- ✚ Maintain a detailed electrical diagram of the building.

C. Electrification & General Electrical Services

- ✚ Attending electrical maintenance works in the building, including:
 - ✚ Internal wiring, lighting, power points, earthing
 - ✚ Minor electrical installations, replacements, and rectifications
 - ✚ Coordination with other vendors/agencies for electrical-related works.
 - ✚ Supervising electrical safety in the premises.

D. Emergency Services

- ✚ Availability on call for emergencies beyond office hours, as and when required.

4. CONTRACT PERIOD:

The contract shall be initially for two year, extendable by another one year based on satisfactory performance and mutual consent, at the same terms and conditions. The successful bidder needs to enter into an agreement with the Bank. The successful bidder needs to provide a Performance Guarantee by way of Bank Guarantee or Security Deposit of Rs.50,000/- (Rupees Fifty Thousand only) valid throughout the period of contract.

5. NATURE OF ENGAGEMENT:

- ✚ Engagement shall be purely on contract basis.
- ✚ The electrician shall not be treated as an employee of the Bank.
- ✚ Monthly remuneration shall be paid as per the accepted tender rate.

6. ELIGIBILITY CRITERIA:

Tenderers should meet the following eligibility conditions:

- ✚ Should be a licensed electrical contractor / supervisor / electrician holding valid Electrical License issued by the competent authority.
- ✚ Minimum 3 years' experience in maintenance of HT installations /transformers (preferably 11 kV systems).
- ✚ Minimum 3 years' experience in handling electrical maintenance of Commercial buildings / institutions / offices & should submit:
 1. Copy of valid electrical license
 2. Experience certificates / work orders
 3. Copy of ID proof and address proof
- ✚ Should be capable of complying with statutory safety requirements.
- ✚ **Electrical contractors / qualified electricians needs to provide separate tenders for Malappuram and Kannur Office Buildings.**

7. MANPOWER REQUIREMENT:

- ✚ One qualified electrician / supervisor shall be deployed exclusively for the Head Office Building/Kannur Office Building.
- ✚ Substitute arrangement shall be made during leave/absence with prior intimation to the Bank.

8. WORKING HOURS:

- ✚ Normal working hours: As per office working hours.
- ✚ Emergency / breakdown duties: As and when required, including holidays.

9. REMUNERATION & PAYMENT TERMS:

- ✚ Quoted rate shall be monthly consolidated remuneration, inclusive of all costs.
- ✚ Payment shall be released monthly upon:
 - ❖ Submission of invoice
 - ❖ Certification of satisfactory service by the competent authority.
 - ❖ By General Administration Wing, Head office, in case of Head Office building & Regional Office, Kannur in case of Kannur Office Building.
- ✚ No additional payment shall be entertained.

10. STATUTORY COMPLIANCE:

- ✚ The contractor shall be solely responsible for:
 - ❖ Compliance with all applicable labour laws.
 - ❖ Payment of statutory dues, if any.
 - ❖ Safety of personnel and equipment during execution of duties.
- ✚ The Bank shall not be liable for any statutory or legal obligations of the contractor.

11. SECURITY & SAFETY:

- ✚ The electrician shall strictly follow all electrical safety norms.

- ✚ Any loss or damage caused due to negligence by the contractor and/or technicians deployed by him, shall be recovered from the contractor.
- ✚ The Bank reserves the right to terminate the contract for safety violations.

12. TERMINATION OF CONTRACT:

- ✚ The contract may be terminated by either party by giving one month's notice, without assigning any reason.
- ✚ The Bank may terminate the contract immediately in case of:
 - ❖ Gross negligence
 - ❖ Safety violations
 - ❖ Unsatisfactory performance

13. EARNEST MONEY DEPOSIT (EMD):

- ✚ EMD: ₹ 5000/- (Rupees Five Thousand only)
- ✚ EMD shall be refunded to unsuccessful bidders.
- ✚ EMD of the successful bidder may be retained as Security Deposit.
